## 1. Introduction

We are committed to protecting your personal data and respecting your privacy.

This Privacy Policy explains what information we collect, how we use it, and what rights you have under GDPR and other privacy regulations.

By using Indo.Earth, you agree to the practices described in this policy.

## 2. Information We Collect

### 2.1 Information You Provide Directly

When using the app, you may provide:

- Name or username
- Email address
- Profile information (bio, avatar, interests)
- Posts, replies, comments, likes
- Uploaded photos or images
- Event submissions or participation
- Messages or interactions with other users

### 2.2 Information Automatically Collected

Indo.Earth is built on **Adalo**, which automatically collects:

- Device information (model, OS version, screen size)
- Log data (IP address, timestamps, browser type)
- Usage information (screens viewed, features used)



## 2.3 Optional Information

Depending on your use of the app, we may store:

- Event attendance
- Groups or categories you follow
- Preferences (e.g., interface settings)

## 3. How We Use Your Information

We process your information to:

- Provide and operate the app
- Manage user accounts
- Display posts, replies, and content to other users
- Improve community interactions
- Maintain platform safety and prevent abuse
- Offer support and respond to inquiries
- Improve site/app performance

We **do NOT sell** your data to third parties.

We **do NOT use your data for advertising.**

## 4. Legal Basis for Processing (GDPR)

For users located in the EU/EEA, we process your data based on:

- **Consent** (when creating an account or uploading content)
- **Contractual necessity** (to give you access to the app)
- **Legitimate interests** (to operate a safe, functional community)
- **Legal obligation** (when required by authorities)

## 5. How Your Data Is Stored

Indo.Earth uses **Adalo** as the technical platform.

Your data is stored securely on Adalo's servers, typically located in the United States or EU, depending on configuration.

Adalo provides:

- Encrypted connections (HTTPS)
- Secure user authentication
- Protected relational databases

## 6. Sharing of Information

Your data may be shared with:

### Other users

When you create posts or upload photos, these are visible within the community.

### Service providers

We may use trusted third-party tools for:

- Hosting
- Analytics
- Error monitoring

These parties only access data needed to deliver their service.

### Legal authorities

If required by law, we may share data to comply with regulations.

We do **not** share your information with advertisers or data brokers.

## 7. User-Generated Content

Any content you post (text, photos, events, comments):

- is visible to other users
- may be stored as long as your account exists
- must follow community guidelines

We reserve the right to remove posts that violate rules or laws.

## 8. Your Rights

Under GDPR and similar laws, you have the right to:

- Access your data
- Request correction of incorrect data
- Request deletion of your data
- Withdraw consent
- Request data export
- Restrict or object to processing
- Delete your account at any time

## 9. Data Retention

We retain your information as long as necessary:

- Account data → until you delete your account
- Posts/replies → until removed by you
- Log data → automatically cleared after a limited period
- Backups → held temporarily for safety before deletion

## 10. Security

We take technical and organizational measures to protect your data:

- Encrypted communication (SSL/HTTPS)
- Password-protected access
- Server-level security provided by Adalo
- Limited access for administrators

However, no platform can guarantee 100% protection.

## 11. Children's Privacy

Indo.Earth is not intended for children under **13 years old**.

We do not knowingly collect data from minors.
